CLAHRCs are collaborations between Universities and their local NHS organisations. They have been created to address the 2nd translation gap – between what is already known to be effective in healthcare and what is routinely used in practice. They are taking various approaches to implementation and the evaluation is looking at these in three CLAHRCs to discover 'what works'. In addition, the study will identify a range of impacts resulting from the implementation and utilisation of evidence (knowledge) for healthcare.
