Entrance Scholarship Terms and Conditions

- a) The Entrance Scholarships scheme is open to candidates who are resident in the UK (or have UK residency status for fee-paying purposes) and who have studied up to and including Level 3 courses.
- b) A candidate must apply for a degree level course or a degree level with foundation year course at Bangor University.
- c) A candidate who is awarded a scholarship must accept Bangor as their firm choice through UCAS and then go on to register on a course at Bangor University in the relevant academic year in order to receive the scholarship payment.
- d) Those applying for a scholarship should normally ensure that they apply to UCAS before the 14 January deadline and they must not accept an offer firmly at any other institution until they are aware of the decision on the scholarship.
- e) In order to receive the scholarship payment, the successful candidates will be expected to meet any conditional entry requirements set out by the University in the year in which the UCAS offer was made.
- f) Entrance Scholarship awards cannot be deferred to a future academic year and can only be paid when the applicant has registered on a course at Bangor University in the relevant academic year.
- g) The University reserves the right to withhold any award if it is found that there is no candidate of sufficient merit.
- h) The University reserves the right to divide and combine scholarships and to alter the amounts payable.
- i) The payment will be made at the end of November.
- j) The University announces the names of the scholarship winners and the names of their schools and colleges on the website, in social media postings and in a media release or announcement - please indicate on the application form if you do not give consent for your name to be published.
- k) If a candidate is awarded a scholarship from a local council, the candidate must provide evidence of their home address.
- If a candidate is eligible for more than one scholarship, this would normally only be for one sports scholarship and one academic scholarship, or one academic scholarship and one Coleg Cymraeg Cenedlaethol scholarship.
- m) In the event of a period of interruption to your studies, including maternity or paternity leave, any payments will be suspended until the candidate returns and progresses to the next stage of their course. However, for students receiving a donor-funded scholarship it may not be possible for the candidate to retain their scholarship if there is a period of interruption to their studies, and requests will be dealt with on a case-by-case basis.
- n) The University reserves the right to withdraw the award immediately under certain circumstances. Those circumstance include, but are not limited to, the following:
 - a. If the candidate is found to be ineligible at a later date;
 - b. The candidate is found to have committed fraud or there was misrepresentation in their scholarship application or examination;
 - c. Non-payment of tuition fees or an outstanding debt to the University; or

- d. Where a candidate, once a student, becomes subject to disciplinary processes under the University's Policies and/or Regulations.
- o) Nothing in these terms and conditions shall limit or exclude the University's or the candidate's liability for:
 - a. death or personal injury caused by its negligence, or the negligence of its personnel, agents or subcontractors;
 - b. fraud or fraudulent misrepresentation; or
 - c. any other liability which cannot be limited or excluded by applicable law.
- p) Subject to the above cases, the University shall not have any liability to the candidate, whether in contract, delict (including negligence), breach of statutory duty, or otherwise, for any indirect or consequential loss arising under or in connection with these terms and conditions, including (but not limited to) any loss arising from the withdrawal of an award.
- q) The candidate agrees to inform the University immediately if the candidate firmly accepts an offer elsewhere. This will terminate any eligibility for a scholarship and the candidate's information will be removed from the process.
